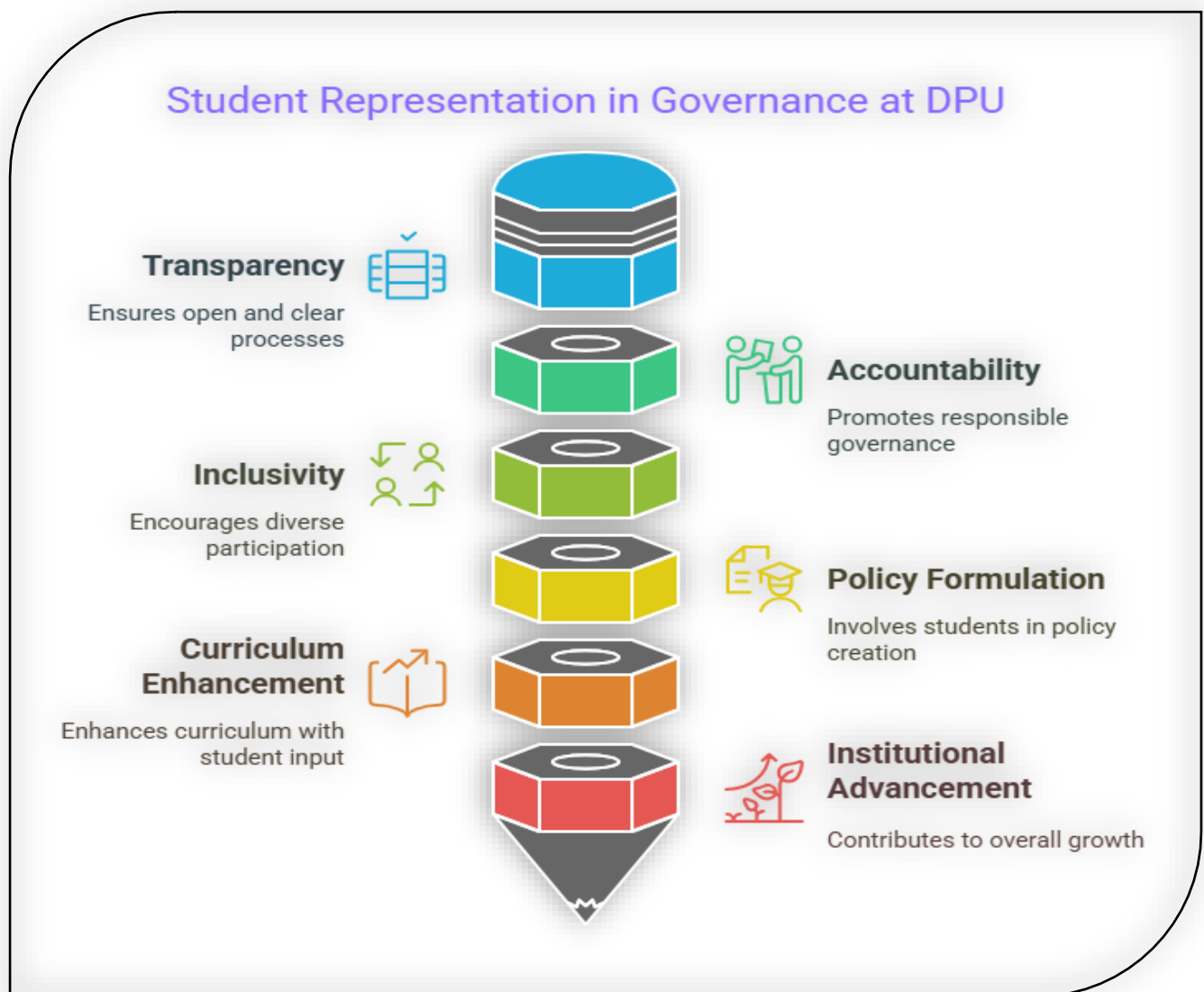


STUDENT REPRESENTATION UNIVERSITY'S GOVERNING BODY

The governance structure of Dr. D.Y. Patil Vidyapeeth (DPU) includes several statutory and non-statutory committees that actively involve student representation. The following governing bodies at DPU integrate student representation:

1. ACADEMIC COUNCIL

4. STUDENTS' GRIEVANCE REDRESSAL COMMITTEE (SGRC)

5. EQUAL OPPORTUNITY CELL (EOC)

The EOC is committed to promoting equal access and opportunities to all students, irrespective of their social, economic, or cultural background. Student representation supports the cell's efforts in identifying and addressing barriers to inclusivity, while fostering an equitable academic environment.

6. INTERNAL COMMITTEE FOR THE STUDENTS WITH DISABILITIES

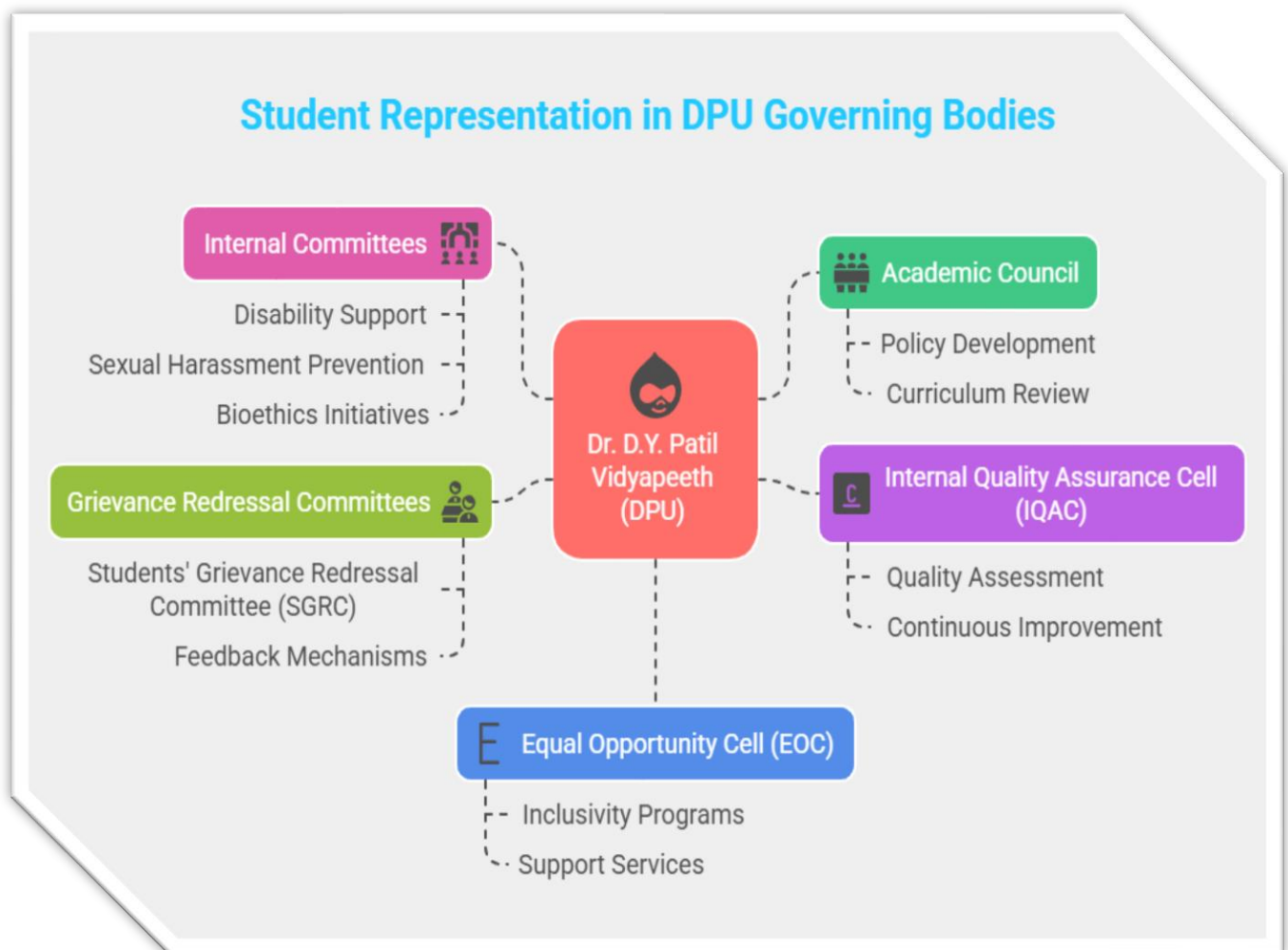

Through this wing, students participate in national and international dialogues, workshops, and academic collaborations that promote ethical practices in science and healthcare.
